- 1. Do ! need to fill out an application for each child? No. Complete the application to apply for free or reduced price meals. <u>Use one Free and Reduced Price School Meals Application for all students in your household.</u> We cannot approve an application that is not complete, so be sure to fill out all required information. Return the completed application to one of your children's schools.
- 2. Who can get free meals? Children in households getting Food Stamps or TANF and most foster children can get free meals regardless of your income. Also, your children can get free meals if your household income is within the free limits on the federal Income Eligibility Guidelines.
- 3. Can foster children get free meals? Yes, foster children that are under the legal responsibility of a foster care agency or court, are eligible for free meals. Any foster child in the household is eligible for free meals regardless of income.
- 4. Can homeless, runaway and migrant children get free meals? If you have not been informed that your child(ren) qualify for free meals, please call the school, homeless liaison, or migrant coordinator.
- 5. Who can get reduced price meals? Your children can get low cost meals if your household income is within the reduced price limits on the federal Income Eligibility Guidelines, shown on this application.
- 6. Should I fill out an application if I got a letter this school year saying my children are approved for free meals? No, if you received a letter indicating that your child has been directly certified as being eligible for free meals, you do not need to fill out the application.
- 7. My child's application was approved last year. Do I need to fill out another one? Yes. Your child's application is only good for that school year and for the first few days of this school year. You must send in a new application unless the school told you that your child is eligible for the new school year.
- 8. I get WIC. Can my child(ren) get free meats? Children in households participating in WIC maybe eligible for free or reduced price meats. Please fill out an application.
- 9. Will the information I give be checked? Yes, we may ask you to send written proof.
- 10.If I don't qualify now, may I apply later? Yes. You may apply at any time during the school year if your household size goes up, income goes down, or if you start getting Food Stamps or getting TANF or other benefits. If you lose your job, your children may be able to get free or reduced price meals.

- 12. May I apply if someone in my household is not a U.S. citizen? Yes. You or your child(ren) do not have to be a U.S. citizen to qualify for free or reduced orice meals.
- 13. Who should I include as members of my household? You must include all people living in your household, related or not (such as grandparents, other relatives, or friends). You must include yourself and all children who live with you.
- 14. What if my income is not always the same? List the amount that you normally get. For example, if you normally get \$1000 each month, but you missed some work last month and only got \$900, put down that you get \$1000 per month. If you normally get overtime, include it, but not if you get it only sometimes.
- 15. We are in the military; do we include our housing allowance as income? If your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. All other allowances must be included in your gross income.
- 16. My spouse is deployed to a combat zone, is her combat pay counted as Income? No, if the combat pay is received in addition to her basic pay because of her deployment and it wasn't received before she was deployed, combat pay is not counted as income. Contact your school for more

We will use your information to determine if your child is eligible for free or reduced price meals, and for administration and enforcement of the lunch and breakfast programs. We MAY share your eligibility information with education, health, and nutrition programs to help them evaluate, fund, or determine benefits for their programs, auditors for program reviews, and law enforcement officials to help them look into violations of program rules.

## Dear Parent/Guardian:

If your children get free or reduced price school meals, they may also be able to get free or low-cost health insurance through Medicaid or NJ FamilyCare. Children with health insurance are more likely to get regular health care and are less likely to miss school because of sickness.

Because health insurance is so important to children's well-being, the law allows us to tell Medicaid and NJ FamilyCare that your children are eligible for free or reduced price meals, unless you tell us not to. Medicaid and NJ FamilyCare only use the information to identify children who may be eligible for their programs. Program officials may contact you to offer to enroll your children (Filling out the Free and Reduced Price School Meals Application does not automatically enroll your children in health insurance).
